National/Regional/Local-Soror Pettiford

- Member annual chapter and Grand Chapter dues and fees for the 2021-2022 fiscal year are payable January 1, 2021 through March 31, 2021. Unless you have a paid in full Life Membership, dues paid after March 31 will incur a late or reinstatement fee. The late fee is payable and applicable from April 1, 2021 to June 30, 2021. A reinstatement fee is payable and applicable if a member is currently not financially or remits annual chapter and Grand Chapter dues and fees after June 30, 2021, or has not paid these fees for two or more years (excluding Life Members). Please refer to Article X, Dues and Fees, Section 1 of the Constitution and Bylaws for more information. The dues financial status table may be viewed here.
- Electronic payment options will be available for chapters to remit dues to headquarters. No wire transfers, no checks, no stamps! Chapters will now submit and remit member dues within the Red Zone. For fiscal officers, the ability for selecting 2021-2022 dues in the Red Zone will be available on February 22, 2021. If you have already received payments for the next fiscal year, you will begin submitting them in the Red Zone on this date as well. Detailed instructions for this process will be emailed to the chapter president and treasurer.
- The 54th National Convention credit will be applied to the 2021-2022 membership dues. As a reminder, credits for dues may only be applied for the national dues and per capita fees, up to a total of \$200 (\$190 national dues plus \$10 per capita). This only applies to one Soror.
- Gastonia Alumnae Chapter dues can be mailed to PO Box (a timeline will be given when mail will be collected each week. Electronic payments may be an option through PayPal; waiting for further directives. There may be drop off date options available. Dues are \$452.00 (\$250.00-Local, \$195.00-National, \$10-Capita, and \$2.00-International)
